£55 for second cat in same double space (sharing a bench space)

2 days £90 for first cat in a double space (metal pen extra)

£85 for second cat in same double space

**Extras:** Metal Pens £10 extra for the weekend, Exhibition Pen £35 (double pen max 2 cats or 4 kittens)

Substitution of a previously entered cat will incur an additional cost of £10 per entry.

closing date.

**Check In:** Saturday and Sunday 07.45-08.30am all exhibitors must check in, present vaccination cards collect catalogue

you should check in both days so we can compile the absence list.

Judging starts 9.00am both days. If you are late we will not wait.

**Cages:** Benching will be in traditional rows with double cages/bench spaces approx. 4'x2'x2'

Two cats or three kittens maximum per double cage. (All your entries will be together) and you may present one

exhibitors name as a benching request.

**Health:** This is a vetted show. All cats should be in date for vaccinations with Feline Enteritis and cat flu, records

must be produced at check in. Any cat showing signs of illness, disease, fleas, fungus or mites will have to leave

the show hall.

ALL CAT CAWS MUST BE CLIPPED BEFOR CHECKING IN, remember they do have four legs.

Any obviously pregnant or lactating cat will be disqualified.

**People Food:** There is a catering outlet upstairs from the show hall, which will be open and serving hot/cold food.

PLEASE DO NOT BRING ALCOHOL TO THE SHOW HALL, IT IS NOT ALLOWED.

Clerks: Want to clerk? Let us know. Clerks will receive a free cat entry for the show. Plus a free lunch.

Registration: With exception of Korats and Household Pet registration with TICA is not necessary to compete for a cat's first

show, but is required for the next show and confirmation of titles and scoring for the TICA

regional/international scoring and awards. All cats in New Traits, Preliminary New Breeds & Advanced New

Breed classes must be registered with TICA in order to be shown.
